**Boxing match Klitschko vs. Adamek, 10<sup>th</sup> September 2011 /  
Retransmission of RTL**

Dear Madams and Sirs,

Referring to the upcoming above mentioned sports event which will be broad-  
casted live by RTL Television we want to state the following:

- 1. The law firm "Dines and English LLC" are the attorneys to the u.s.-based rightsholders of the Adamek-Klitschko fight. „Dines and English LLC" does not represent RTL Television GmbH.*
- 2. We confirm that RTL has authorized the German lawyer Kurt-Michael Loitz of the law firm „Unverzagt Von Have" to write a letter to „Dines and English" to confirm that RTL has – of course – not acquired a license of the match outside German speaking territories (Germany, Switzerland, Austria).*
- 3. RTL Television has the right to permit the retransmission of its channel simultaneously, unaltered and unabridged which is stipulated in Art. 10 of the EC Directive 93/83/EEC of 27th September 1993 on the coordination of certain rules concerning copyright and related rights applicable to satellite broadcasting and cable retransmission and Art. 3 of the EU Copyright in the Information Society Directive 2001/29 of 22th May 2001. Both Directives are applicable in Poland. As explicitly stated in all retransmission agreements the retransmission right does not cover other rights held by other rightholders or other collecting societies such as AGICOA or collecting societies for music rights.*


